

OrchardNet Website and Subscription Terms and Conditions

1 Acceptance Of This Agreement

Your access to and use of this website ("the Website") is subject exclusively to these Terms and Conditions. You will not use the Website for any purpose that is unlawful or prohibited by these Terms and Conditions. By using the Website you are fully accepting the terms, conditions and disclaimers contained in this notice. If you do not accept these Terms and Conditions you must immediately stop using the Website.

2 Use of Data

The subscriber agrees and acknowledges that data entered in this website will be available to AgFirst HB Ltd, and may be used anonymously in reports/analyses made available to other clients. AgFirst HB Ltd agrees that all data contributed by clients will be held confidential and private to that client, except where:

- a Data is used in group analyses (eg, Block Analysis), in which case data shall always be anonymous so the subscriber will not be identified.
- b The subscriber/user assigns a block to a Packhouse or Exporter, which is an agreement that certain aspects of that block's data will be shared with the Packhouse/Exporter and shall be identifiable to the grower.
- c The subscriber/user gives management rights to a Packhouse or Exporter, which is an agreement that the Packhouse/Exporter will be able to access all of the grower's data.
- d The subscriber/user's company is associated with a registered OrchardNet Consultant other than AgFirst HB Ltd, in which case all the company's data shall be available to that consultant and identifiable.

If an orchard or property changes hands, Agfirst have the right to copy the block structure to the new client, but not the data contained within. If the new owner wishes to capture historical block data this will only be allowed with the original owners written consent.
